- Additional non-budgeted expenses included \$790 for All American awards, \$800 in Web hosting services. There were a reduction in program donations.
- Batteries may need to be purchased for our laptops.

- About 1/3 of our shooters are first time state shoot shooters this year
- Forecasting is in line with our budgeted deficit of \$695. Forecast is a little undetermined due to the cancellation of Event 6 plus a slightly reduced attendance, which all results in fewer targets throw an hence, revenue.
- Had \$1750 additional Event Donations vs budget
 - Thanks to Tex Hollis, Alan Sikes, Trey Heusel and an anonymous donor.
- Additional non budgeted expenses included \$790 All American awards, \$800 in Web Services. Also, we had a reduction in program donations due to some shooter retirements and businesses no longer donating.
- Overall LTA is fiscally healthy with good cash reserves

Other New Business

- The Board wishes to revise the bylaws to allow the Board to adjust the amount of the daily fees collected at each shoot. Currently, it is stipulated that the fee shall be \$3 / day in the bylaws. See Article I, Section D below.

“Every Louisiana Gun Club shall be responsible for collection and remitting all daily shooting fees, whether ATA or LTA. The sponsoring Club shall pay to the LTA an amount equal to the total of Three Dollars (\$3.00) per day for each shooter participating in a registered program. The club shall pay Three Dollars (\$3.00) for each shooter participating in each registered league event.”

The proposed revised language would be as follows:

“Every Louisiana Gun Club shall be responsible for collection and remitting all daily shooting fees, whether ATA or LTA. The sponsoring Club shall pay to the LTA an amount **established by the LTA Board** per day for each shooter participating in a registered program. The club shall pay **an amount established by the LTA Board** for each shooter participating in each registered league event.”

The Board has no current plans to increase the daily fee amount. It only wishes to revise the language so that any change to the daily fee doesn't have to go through the nearly yearlong process of revising the bylaws to adjust the amount.
